Keith De Lacy these days is considered one of the top half dozen Company Directors in Queensland. Yet just a decade ago he was wallowing in the dark world of politics, as Queensland Treasurer no less.

How has he made this remarkable transition? And from a regional centre like Cairns, so far from the corporate headquarters of Sydney, Melbourne and Brisbane? And without any prior experience of the Board room? What skills does he bring, what lessons has he learned, and what lessons are in it for you?

Keith is vice-president of the Queensland Division of the Australian Institute of Company Directors (AICD) and regularly presents on behalf of the division on corporate governance issues of interest to members.

He is Chairman of listed companies Macarthur Coal and Trinity Group, as well as chairing the important Queensland institutions Queensland Sugar and Cubbie Group. He is also a director of the Reef Casino. He has taken three companies through an IPO (Macarthur, Trinity and CEC). He has been (and still is) chairman of a whole range of not-for-profits.

Keith is also Chairman of the Global Sugar Alliance, a group of sugar exporting countries seeking freer trade in sugar on global markets.

He last year gained an Order of Australia Medal (AM) for services to Queensland. He has previously been awarded honorary doctorates from both James Cook and Central Queensland Universities, a University of Queensland Gatton Gold medal, and the Centenary medal.

He is a successful author having published his book *Blood Stains the Wattle* in 2002.

Keith was born in Cairns, and still calls Cairns home!
